



International Student Certification of Finances

2018 - 2019

All international students are required to submit a Certification of Finances before clearance can be given for the issuance of an I-20 form. At that time you will be required to submit a processing fee of \$100.00 to be used for postage and expenses relating to the acquisition of your I-20.

The Certification of Finances will assist Warner University in obtaining complete financial information about funding available to international applicants who want to study in the United States. Strict government regulations, rising educational costs and economic conditions have made verification of financial resources of international applicants essential. By completing and returning this form to Warner University, an applicant, if admitted, may obtain Warner University's authorization and issuance of a Certificate of Eligibility (I-20 or DS-2019). If parents and/or sponsors are unable to obtain a bank official's verification, it is recommended that institutions forward a copy of the International Student Financial Aid Application to the family for completion. The institution should attach a copy of this Certification of Finances. U.S. consuls scrutinize the statements of financial resources given by nonimmigrant visa applicants. This Certification will help such officials make their decisions and expedite visa issuance.
