This policy is in place to facilitate the work of University personnel and students through parking control and movement of motor vehicles while on campus.

All vehicles operated on the campus of Warner university by students, faculty and staff **MUST BE REGISTERED** with Campus Safety and Security within 10 days of such use. Regulations are in effect and enforced throughout the academic year (August –July). By registering your vehicle with Campus Safety and Security you are agreeing to drive in a safe and sensible manner at all times. Obeying the campus speed limit of 15MPH and driving the proper way on designated roads and parking in appropriate areas is a must.

The texting on a cellular or any electronic device while driving on campus is prohibited.

Vehicle stickers will be given to students, faculty and staff after registration of vehicles is complete. Place the sticker on the top left driver's side on the **outside** of the windshield.



## Do not stop or park

### in the following areas:

- **Fire Lanes** per Florida State Statute these must remain clear for emergency vehicles.
- **Within 15ft. of a fire hydrant** per Florida Statue 316.1945
- **Handicapped parking spaces** (This includes the white loading area) per Florida Statue 316.1959
- **On any sidewalk or bicycle path. Median grass areas on any roads** (i.e. Presidents Drive at South Lake Wales Church of God).
- **Any place marked with “No Parking” signs or barrier tape.**
- **Any painted areas, curbed or other areas where the marking would prohibit parking.** (i.e. the area behind Fulton and Raines).

#### *Fulton and Raines Parking lot:*

There is no parking on the East side of the entrance/exit road and fire Lanes.

#### *Clary Center:*

No parking in the grass in front of the Clary building.

#### **Pond side parking:**

There will be no parking near the pond area east of the courtyard.

There is no parking or driving on any sidewalks. There is no parking in the center courtyard.

#### **Moving Infarctions::**

(Reckless/careless driving, speeding, running a stop sign, failure to heed security officers directions, anything dealing with a vehicle while it is in motion).

1st Offense \$25.00

2nd Offense \$35.00

3rd Offense \$50.00

4th Offense \$100.00

5th Offense revokes driving privileges on campus

#### **Non-Moving Infractions:**

(Parking violation (not including handicap), no/multiple or improper display of a parking permit, anything dealing with vehicle not in motion).

1st Offense \$15.00

2nd Offense \$20.00

3rd Offense \$40.00

4th Offense & up \$50.00

#### **Handicap Parking without Permit:**

1st Offense \$75.00

2nd Offense & up \$150.00

Students will have the opportunity to appeal any citation if they feel they have been wrongly cited.. This may be done by contacting the Director of Safety and Security at 863.638.7232. Unpaid citations will result in a hold being place on the students account until paid in full.
